**Broadband/Fiber:** City Clerk/Treasurer requested a quote from Vibrant Broadband/Fiber and Charter Communications to bring Fiber into city limits due to a resident request. Charter did not respond, and Vibrant Broadband gave the Clerk an estimated quote of \$660,000. The council stated that since internet speeds had only been complained about by a couple residents this would not be cost-effective to the residents. The city would not qualify for any grants. In most cases it is the providers that cover these costs and not the cities that pay for them. To bring fiber to the city a minimum of 100 residences would need to commit to hooking up for this to be cost effective for a provider.

**Slabjacking:** Council Member Clark motioned to allow Nissen Slabjacking to slabjack 32 Linier Feet along Atlantic Avenue and around the Firehall for \$960.00. Council Member Hunt seconded the motion, motion carried.
