Moore Engineering Update: Jon Pauna and Josiah Rostad were present from Moore Engineering to give an update on the first phase of the upcoming street project. If plans keep progressing the city will have another informational meeting for the residents. The council discussed additional tasks and time requirements for the Public Works Supervisor and the City Clerk with the upcoming street project. Council Member McGillivray motioned to have Moore Engineering put together a cost estimate for a sanitary sewer pond system for \$4,000. Council Member Hunt seconded the motion, motion carried.
